

TERMS & CONDITIONS GENERAL

1.2 These Terms and Conditions (“T&C”) apply to the usage of the Games through Wifflip.com (“Website”) through related enabling internet, mobile or other platforms by you (“You” or “the Player”).

1.3 These T&C constitute a binding agreement between You and Wifflip.com.

1.4 These T&C come into force as soon as you register an account, and by doing which you signify to Wifflip.com that you have read these T&C and accept them. By using any of the Website you signify that you agree with these T&C.

1.5 You must read these T&C carefully in their entirety before registering an account. If you do not agree with any provision of these T&C you must not use or continue to use the Website.

1.6 You fully understand and agree to be bound by the terms and conditions contained herein and as may be amended by Us from time to time.

1.7 Wifflip.com reserves the right to modify and amend this Agreement at any time with or without notice.

1.8 Rules and explanations in respect to the games provided separately on the Website are incorporated into these T&C by reference.

1.9 Wifflip is not available for the following countries: Anguilla, Antigua & Barbuda, Argentina, Aruba, Barbados, Bahamas, Belize, Bermuda, Bolivia, Bonaire, Brazil, British Virgin Islands, Canada, Cayman Islands, China, Chile, Clipperton Island, Columbia, Costa Rica, Cuba, Curacao, Dominica, Dominican Republic, El Salvador, Greenland, Grenada, Guadeloupe, Guatemala, Guyana, Haiti, Honduras, Jamaica, Japan, Martinique, Mexico, Montserrat, Navassa Island, Paraguay, Peru, Puerto Rico, Saba, Saint Barthelemy, Saint Eustatius, Saint Kitts and Nevis, Saint Lucia, Saint Maarten, Saint Martin, Saint Pierre and Miquelon, Saint Vincent and the Grenadines, South Korea, Suriname, Turks and Caicos Islands, United States of America, Uruguay, US Virgin Islands, Venezuela. Azerbaijan, Cambodia, Canada, China, France, India, Indonesia, Laos, Malaysia, Myanmar, Papua New Guinea, Qatar, Russia, South Korea, Thailand, Turkey, Ukraine, United States of America. Indonesia.

1.12 By accepting these Terms and Conditions you confirm that you know and understand the rules of the games offered on the Website. It is at your discretion to familiarise yourself with the theoretical payout percentage of each game.

1.13 Certain games may be unavailable in certain jurisdictions, as required by policies of game providers which may change from time to time.

ELIGIBILITY TO USE WIFFLIP.COM'S SERVICES:

2.1 You may participate in any of the Games if and only if:

2.1.1 You are over eighteen (18) years of age or such higher minimum legal age of majority as stipulated in the jurisdiction of Your residence; and

2.1.2 It is legal for You to participate in the Games according to applicable laws in the jurisdiction of your residence.

2.2 It is entirely and solely Your responsibility to enquire and ensure that You do not breach laws applicable to you by participating in the Games.

YOUR MEMBER ACCOUNT

3.1.1 In order for you to be able to place wagers using any of the Website, you must first register with Wiffflip.com and open an account ("Member Account").

3.1.3 As part of the registration process You can choose your username or the system will assign you a new username. You have to use your Solana wallet to login into the Website. It is Your sole and exclusive responsibility to ensure that Your login details are kept securely. You must not disclose Your login details to anyone. Wiffflip.com is not responsible for any abuse or misuse of Your Member Account by third parties due to Your disclosure, whether intentional or accidental, whether active or passive, of your login details to any third party.

3.1.4 Wiffflip.com reserves the right to refuse to register an Account or close Your Account. However all virtual funds within Your Account will be returned and all contractual obligations already made honoured.

3.1.5 Wiffflip.com prohibits player collusion and do not allow any kind of robots and programmed devices to participate in game play. Wiffflip.com reserves the

right to void any game play which results from the use of robots and/or programmed devices.

3.1.6 It's forbidden for players from United States of America, Greece, United Kingdom, Jersey, Gibraltar, Spain, France and its overseas territories (Guadeloupe, Martinique, French Guiana, Réunion, Mayotte, St. Martin, French Polynesia, Wallis and Futuna, New Caledonia), Netherlands, Sweden, Israel, Lithuania, Slovakia, Belgium, Switzerland, Turkey, Dutch West Indies or Curacao to play at Wiffflip.com. This includes both FIAT and Cryptocurrencies.

3.1.7 Upon requesting a self exclusion, Wiffflip.com will immediately close that account and prevent the player to play on that particular account. It's the player's responsibility to notify Wiffflip.com of any other accounts the player might have and promise not to open any other accounts. Wiffflip.com will make reasonable efforts to try to prevent the opening of new accounts but it's the player's sole responsibility to make sure no other accounts are created. Wiffflip.com cannot be held accountable for potential losses on other accounts.

3.1.9 Kindly note that due to the nature of Cryptocurrencies, deposit limits are not possible for this particular currency. We do offer the facility to take a break from gambling however, and if you need any help applying this, we kindly ask you to contact us.

3.1.10 For transaction security, we use SSL encryption. All customer data will be treated as confidential and will not be sold to third parties.

3.1.11 Kindly note that withdrawals has to be made to the same method that you deposited with.

3.2 DEPOSITS INTO YOUR MEMBER ACCOUNT

3.2.1 You may only participate in Games if you have sufficient Virtual Funds on Your Member Account for such participation. For the avoidance of doubt, Virtual Funds shall mean \$WIF on the solana blockchain. Wiffflip.com will not grant any form of virtual credit whatsoever for participation in any of the Games.

3.2.2 Wiffflip.com can, under certain circumstances, credit a player's account with so called "bonus". The conditions for the crediting of the bonus (e.g. First Deposit Bonus) and the amount of the bonus is determined by Wiffflip.com and set out on the website from time to time. For promotions that are currently

running please follow this link: promotions. If an account contains both the Virtual Funds and bonus funds, the bonus funds will only be available for wagering once the existing Virtual Funds have been used. Before fulfilling the bonus turnover conditions if you transfer or withdraw the main deposit amount, bonus funds and all winnings from this bonus will be forfeited.

3.2.3 To deposit Virtual Funds into your Member Account, you can transfer Virtual Funds from your personal wallets or other Virtual Funds related accounts. The maximum amount of deposit depends on the payment method you decide to use and will appear when choosing the payment method.

3.2.4 Wifflip.com is not a financial institution and thus should not be treated as such. Your account will not bear any interests.

3.2.5 Deposited amounts are available on the Account within a reasonable amount of time after the confirmation of the deposit. Before a withdrawal can be made, all previous deposits need to be confirmed.

3.2.6 We reserve the right to use additional procedures and means to verify your identity (Know Your Client) when effecting deposits into your Account. This could include (but is not limited to) a selfie with a document or form of identification.

3.2.7 It's the responsibility of the player to ensure that all documents as a part of the KYC process are genuine. Faked or fraudulent documents provided may result in a confiscation of deposits and potential winnings of the player.

3.2.8 Wifflip.com is not an exchange and therefore does not execute any conversion between Solana and any Fiat currency.

3.2.9 Kindly note that bonuses come with specific bonus terms and conditions ("Bonus Terms and Conditions"). These can be found here.

3.2.10 You may only use your own personal cryptos to fund your Account.

3.3 WITHDRAWALS FROM YOUR MEMBER ACCOUNT

3.3.1 While Wifflip.com will endeavour to pay out withdrawals immediately, some withdrawals may take longer than others. Wifflip.com shall try to pay out withdrawals within 1 hour, however in some cases, withdrawals may take longer; this would clearly be stated when you choose a method of withdrawal.

3.3.2 Solana withdrawals will be made to your stated Wiffflip.com wallet. To withdraw any Virtual Funds which have been deposited, we require the block chain to give at a minimum 1 confirmation of your last deposit, before a withdrawal can be made.

3.3.3 If we mistakenly credit your Member Account with winnings that do not belong to you, whether due to a technical error in the pay-tables, or human error or otherwise, the amount will remain our property and will be deducted from your Member Account. If you have withdrawn funds that do not belong to you prior to us becoming aware of the error, the mistakenly paid amount will (without prejudice to other remedies and actions that may be available at law) constitute a debt owed by you to us. In the event of an incorrect crediting, you are obliged to notify us immediately by email.

3.3.4 You acknowledge that the Virtual Funds are consumed instantly and Wiffflip.com do not provide for refunds or cancellation. Wiffflip.com reserves the right to payout substantial wins in monthly installments.

3.3.5 Wiffflip.com agents reserve the right to carry out additional verification procedures, if deemed necessary by the Wiffflip.com payments team. Such verifications may include copies of a player's passport, national Identity Card, copies of a player's utility bills.

3.3.6 In order to make a withdrawal, a player must play through active deposited amounts at least once prior to withdrawal. This procedure is in line with anti money laundering practices. The player is fully responsible for paying all fees and taxes applied to their winnings according to the laws of the jurisdiction of the player's residence.

3.3.7 Upon a player winning a significant amount of money defined according to Wiffflip.com's own discretion, the winnings will be needed to be verified with the relevant game provider. This means the withdrawal may take longer than the 10 minute average.

3.3.8 If you withdraw to your Web 3.0 wallet, we do not charge any withdrawal fee. You only need to pay for the network gas fee.

3.3.9 The casino is not a financial institution and thus should not be treated as such. Your account will not bear any interests and no conversion or exchange services (including fiat-crypto exchange) will be offered at any time.

3.3.10 The Wiffflip.com reserves the right to check your identity prior to processing payouts and to hold any refund or withdrawals for the time needed to check your identity. In case you provide false or incompleting Personal Data, the withdrawal can be refused and the Player Account terminated, of which you will be informed by email. Reporting by the Casino to applicable regulatory bodies of actions performed by the player may be required.

3.4 CLOSING OF ACCOUNT

3.4.1 You may close Your account by contacting customer support. Wiffflip.com.

3.4.2 Wiffflip.com reserves the right to close Your Member Account and to refund to You the "Account balance", subject to the deduction of relevant withdrawal charges, at Wiffflip.com's absolute discretion and without any obligation to state a reason or give prior notice

3.4.3 Kindly note that withdrawals has to be made to the same method that you deposited with. If you for example deposited with Solana, the winnings from that deposit has to be sent back via Solana.

3.4.4 The Company reserves the right to ask for proof of age from the player and limit access to the Website or suspend the Player Account to those players who fail to meet this requirement.

3.4.6 The Casino cannot guarantee successful processing of withdrawals or refunds in the event that player breaches this Restricted Countries policy.

3.4.8 You warrant not to use any form of VPN or other methods or program fit to hide your IP or your state of origin. The usage of a VPN is only allowed with written consent from the support team. Users or customers found to use a VPN without the companies consent will be excluded from all services on the website, and all remaining funds will be frozen indefinitely. You acknowledge that you are solely responsible for all losses that might occur to you over your VPN usage without the companies consent, including but not limited to financial losses and the loss of your account on the website.

YOUR OBLIGATIONS AS A PLAYER:

4.1 You hereby declare and warrant that:

4.1.1 You are over 18 years of age or such higher minimum legal age of majority as stipulated if the jurisdiction of Your residence (e.g. Estonia – 21 years) and, under the laws applicable to You, legally allowed to participate in the Games offered on the Website.

4.1.2 You participate in the Games strictly in your personal non-professional capacity for recreational and entertainment reasons only;

4.1.3 You participate in the Games on your own behalf and not on behalf of any other person;

4.1.4 All information that You provide to Wifflip.com during the term of validity of this agreement is true, complete, and correct, and that You shall immediately notify Wifflip.com of any change of such information;

4.1.5 You are solely responsible for reporting and accounting for any taxes applicable to You under relevant laws for any winnings that You receive from Wifflip.com;

4.1.6 You understand that by participating in the Games you take the risk of losing Virtual Funds deposited into Your Member Account;

4.1.7 You shall not be involved in any fraudulent, collusive, fixing or other unlawful activity in relation to Your or third parties' participation in any of the Games and shall not use any software-assisted methods or techniques or hardware devices for Your participation in any of the Games. Wifflip.com hereby reserves the right to invalidate any wager in the event of such behaviour;

4.1.8 You understand that \$WIF are not considered a legal currency or tender and as such on the Website they are treated as virtual funds with no intrinsic value.

4.1.9 You understand that \$WIF value can change dramatically depending on the market value.

4.1.10 You are not allowed to use any payment methods that belong to a Third party or person. If we determine during the security checks that you have violated this condition, your winnings will be confiscated and the original deposit will be returned to the owner of the payment account. The Company is not responsible for the lost funds deposited from third party accounts.

4.2 You are not allowed to transfer Virtual Funds from your Account to other players or to receive Virtual Funds from other players into your Account, or to transfer, sell and/or acquire, user accounts.

4.3 Games played on Our site should be played in the same manner as games played in any other setting. This means that players should be courteous to each other and avoid rude or obscene comments.

4.4 Some circumstances may arise where a wager is confirmed, or a payment is performed, by us in error. In all these cases Wiffflip.com reserves the right to cancel all the wagers accepted containing such an error, or to correct the mistake made re-settling all the wagers at the correct prices/spreads/terms that should have been available at the time that the wager was placed in the absence of the error.

4.5 Should the user become aware of possible errors or incompleteness in the software, he/she agrees to refrain from taking advantage of them. Moreover, the user agrees to report any error or incompleteness immediately to Wiffflip.com. Should the user fail to fulfil the obligations stated in this clause, Wiffflip.com has a right to full compensation for all costs related to the error or incompleteness, including any costs incurred in association with the respective error/incompleteness and the failed notification by the user.

4.6 In the event a game is started but miscarries because of a failure of the system, Wiffflip.com shall refund the amount wagered in the game to the User by crediting it to the User's Account or, if the account no longer exists, by paying it to the User in an approved manner; and if the User has an accrued credit at the time the game miscarried, credit to the User's Account the monetary value of the credit or, if the account no longer exists, pay it to the User in an approved manner.

4.7 Wiffflip.com reserves the right to reject or limit wagers. The user is not permitted to wager an amount exceeding his/her personal account. Wins are credited to the personal account of the user.

4.8 Wiffflip.com reserves the right to retain payments, if suspicion or evidence exists of manipulation of the casino system. Criminal charges will be brought against any user or any other person(s), who has/have manipulated the casino system or attempted to do so. Wiffflip.com reserves the right to terminate and/or, change any games or events being offered on the Website.

4.9 We reserve the right to require some verification in case of suspicious or fraudulent transactions.

4.10 Wiffflip.com reserves the right to declare a wager void partially or in full if Wiffflip.com, at its own discretion, would deem it obvious that any of the following circumstances have occurred:

4.10.1 You, or people associated with you may directly or indirectly influence the outcome of an event, to obtain an unlawful advantage,

4.10.2 You and or people associated with you are directly or indirectly avoiding the rules of Wiffflip.com,

4.10.3 the result of an event has been directly or indirectly affected by criminal activity,

4.10.4 wagers have been placed that would not have been accepted otherwise, but that were accepted during periods when the website have been affected by technical problems,

4.10.5 due to an error, such as a mistake, misprint, technical error, force majeure or otherwise, wagers have been offered, placed and or accepted due to this error.

4.10.6 If a player's deposit fee is too low and is flagged by blockchain or similar site as "not enough fee to relay" Wiffflip.com reserve the right to confiscate the winnings if Wiffflip.com at their own discretion deem the transaction and behavior of the player to be fraudulent in nature.

PRIVACY POLICY

5.1 You hereby acknowledge and accept that it is necessary for Wiffflip.com to collect and otherwise use Your personal data in order to allow You access and use of the Website and participation in the Games.

5.2 Wiffflip.com hereby acknowledges that in collecting Your personal details as stated in the previous provision, We are bound by the Data Protection legislation. Wiffflip.com will protect your personal information and respect your privacy in accordance with best business practices and applicable laws.

5.3 Wiffflip.com will only use Your personal data to allow you to participate in the Games and to carry out operations relevant to Your participation in the

Games. All members of the staff shall have access to Your personal data for the purpose of performing their duties.

5.4 Your personal data will not be disclosed to third parties, unless such disclosure is necessary for processing of your requests in relation to Your participation in the Games. You hereby consent to such disclosures.

5.5 As an individual you may exercise your right to access the data held about you by Wifflip.com by submitting your request in writing. Although all reasonable efforts will be made to keep your information updated, you are kindly requested to inform us of any change referring to the personal data held by Wifflip.com. In any case if you consider that certain information about you is inaccurate, you may request rectification of such data. You also have the right to request the blocking or erasure of data which has been processed unlawfully.

5.6 In order to make Your visit to the Website more user-friendly, to keep track of visits to the Website and to improve the service, Wifflip.com collects a small piece of information sent from Your browser, called a cookie. You can, if you wish, turn off the collection of cookies (please refer to your browser instructions as to how to do this). You must note, however, that turning off cookies may restrict Your use of the Website.

5.7 If, while playing at Wifflip.com, you win a sum regarded by Wifflip.com Management as worthy of publicity, you agree to make yourself available for any event of such nature arranged by Wifflip.com. While Wifflip.com protects all personal data entrusted to us, we reserve the right to use first names and the first initial of the last name in any Wifflip.com announcement about promotion results or on the website or lobby.

5.8 We may also inform you of changes, new services and promotions We think that You may find interesting. If you do not wish to receive direct marketing data you may opt out of such service through the member account.

COMPLAINTS

6.1 You may contact our customer service according to the instructions located at the Website to give us any complaints regarding our services.

6.2 Complaints are handled in the support department and escalated in the organization of Wifflip.com in the case that support personnel do not solve the

case immediately. The player shall be informed about the state of the complaint to a reasonable level.

6.3 In the event of any dispute, you agree that the records of the server shall act as the final authority in determining the outcome of any claim.

6.4 You agree that in the unlikely event of a disagreement between the result that appears on your screen and the game server, the result that appears on the game server will prevail, and you acknowledge and agree that our records will be the final authority in determining the terms and circumstances of your participation in the relevant online gaming activity and the results of this participation.

6.5 When we wish to contact you regarding such a dispute, we will do so by using any of Your Contact Details.

6.6 You agree that any claim and/or cause of action arising out of or related to these Terms and Conditions or a service provided by the Casino must be filed within one (1) year after such claim or cause of action arose.

6.7 Casino is to acknowledge a complaint started by the account holder only. It is forbidden to and you can therefore not assign, transfer, hand over or sell your complaint to the third party. The casino will dismiss the complaint if the matter is handed over to be conducted by the third party and not the original account owner.

LIMITATION OF LIABILITY

7.1 You enter the Website and participate in the Games at your own risk. The Website and the Games are provided without any warranty whatsoever, whether express or implied.

7.2 Without prejudice to the generality of the preceding provision, Wiffflip.com, its directors, employees, partners, service providers:

7.2.1 do not warrant that the software or the Website is/are fit for their purpose;

7.2.2 do not warrant that the software and Website are free from errors;

7.2.3 do not warrant that the Website and/or Games will be accessible without interruptions;

7.2.4 shall not be liable for any loss, costs, expenses or damages, whether direct, indirect, special, consequential, incidental or otherwise, arising in relation to Your use of the Website or Your participation in the Games.

7.3 You hereby agree to fully indemnify and hold harmless Wiffflip.com, its directors, employees, partners, and service providers for any cost, expense, loss, damages, claims and liabilities howsoever caused that may arise in relation to your use of the Website or participation in the Games.

7.4 Nothing published by or on behalf of Wiffflip.com constitutes solicitation or recommendation to enter into any security or investment. Neither content nor data published by Wiffflip.com should be relied upon for investment, trading, or security purposes. Links to other sites do not constitute endorsement and should not be deemed as such, nor should such links be considered approval by Wiffflip.com of the linked site, its owner, or its content. It is strongly advised that anyone perform independent research prior to making financial or investment decisions, along with seeking the advice of a qualified professional.

7.5 By accepting these Terms and Conditions you confirm your awareness of the fact that gambling may lead to losing money. The Casino is not liable for any possible financial damage arising from your use of the Website.

BREACHES, PENALTIES AND TERMINATION

8.1 If You breach any provision of these T&C or Wiffflip.com has a reasonable ground to suspect that You have breached them, Wiffflip.com reserves the right not to open, suspend, close Your Member Account, withhold payment of your winnings and apply such funds on account of any damages due by You.

8.2 You acknowledge that Wiffflip.com shall be the final decision-maker of whether you have violated Wiffflip.com's rules, terms or conditions in a manner that results in your suspension or permanent barring from participation in our site.

INTELLECTUAL PROPERTY RIGHTS

9.1 All website design, text, graphics, music, sound, photographs, video, the selection and arrangement thereof, software compilations, underlying source code, software and all other material contained within the Website are subject to copyright and other proprietary rights which are either owned by us or used under licence from third party rights owners. To the extent that any material

contained on the Website may be downloaded or printed then such material may be downloaded to a single personal computer only and hard copy portions may be printed solely for your own personal and non-commercial use.

9.2 Under no circumstances shall the use of the Website grant to any user any interest in any intellectual property rights (for example copyright, know-how or trademarks) owned by us or by any third party whatsoever.

9.3 No rights whatsoever are granted to use or reproduce any trade names, trademarks or logos which appear on the Website except as specifically permitted in accordance with the Terms of Use.

SEVERABILITY

10.1 If any provision of these T&C is held to be illegal or unenforceable, such provision shall be severed from these T&C and all other provisions shall remain in force unaffected by such severance.

INACTIVE/DORMANT PLAYER ACCOUNTS

11.1 This section applies for registered account only. If no transaction has been made to your player account at Wifflip.com in thirty months, your account will be deemed as dormant and we will return your balance back to you. We'll make reasonable efforts trying to contact you regarding the withdrawal of the funds, but if we are not able to reach you, the funds will be retained by Wifflip.com as an admin fee.

11.2 An inactive Account is a Player Account which a player has not logged into or logged out of for twelve consecutive months. If your Player Account is deemed to be inactive, Wifflip.com reserves the right to charge a monthly administrative fee of €10 or the equivalent in another currency (or the current balance of your Player Account, if less) as long as the balance of your Player Account remains positive. You authorize Wifflip.com to debit this fee from your Player Account on the beginning of the month following the day on which your Player Account is deemed inactive, and on the beginning of every subsequent month that your Player Account remains inactive. Wifflip.com will stop deducting the fee if the account balance is zero or if the account is re-activated.

ASSIGNMENT

12.1 Wiffflip.com reserves the right to assign or otherwise lawfully transfer this Agreement. You shall not assign or otherwise transfer this Agreement.

APPLICABLE LAW AND JURISDICTION

13.1 The Terms and Conditions stipulated below are effective as of July 2nd, 2024. Before using the website Wiffflip.com, please read Terms and Conditions carefully. The fact of using the website confirms your consent with the Terms and Conditions.

13.2 Do you have any questions regarding the terms and conditions? Do they sound very bureaucratic and confusing? They're not meant to, but if you feel that way, please contact our support heroes via twitter or team@Wiffflip.com. They're available 24 hours a day, 7 days a week, even on Christmas Eve, so you might as well come and say hello!

ADVANTAGE PLAY

14.1 Should the Casino become aware of any user who has accepted the bonus or a promotion with sole purpose of creating a positive expected value on bonus return by using known practices aimed at securing a cash out of said bonus or at any way try to take advantage of bonuses received by Wiffflip.com, then Wiffflip.com will enforce immediate confiscation of winnings and closure of the account with the right to withhold any further withdrawals. An example of advantage play would be delaying any game round in any game, including free spins features and bonus features, to a later time when you have no more wagering requirement and/or performing new deposit(s) while having free spins features or bonus features still available in a game, the Casino reserves the right to withhold any withdrawals and/or confiscate all winnings.

REFUND POLICY

15.1 Refunding is not possible.

ANTI-FRAUD POLICY

16.1 The Company has a strict anti-fraud policy and utilises various anti-fraud tools and techniques. If the player is suspected of fraudulent actions including, but not limited to:

16.1.1 participating in any type of collusion with other players;

16.1.2 development of strategies aimed at gaining of unfair winnings;

16.1.3 fraudulent actions against other online casinos or payment providers;

16.1.4 stolen funds;

16.1.5 creating two or more accounts;

16.1.6 low risk roulette play where the player betting equal stakes for both black/red or even/odd covering 25 or more out of 37 numbers on the table. (Placing bets on black/red only covers 36 of 37 possible numbers);

16.1.7 other types of cheating

16.1.8 Or becomes bankrupt in the country of their residence, the Company reserves the right to terminate such Player Account and suspend and/or cancel all payouts to the player. This decision is at the sole discretion of the Company and the player will not be notified or informed about the reasons of such actions. The Company also reserves the right and may be obliged to inform applicable regulatory bodies of the fraudulent actions performed by the player.

16.2 In the event of hack activities at the account, the casino reserves the right to;

16.2.1 charge the player a sum equivalent to the players available balance funds in order to compensate damages and expenses suffered by an incurred as a result of hack;

16.2.2 claim further damages and financial losses from the player by contacting them via one of the methods provided during the registration process (i.e. phone, e-mail, etc.);

16.2.3 close player's personal account and/or discard all and any winnings gained as a result of such act or attempt to act.

16.3 The Casino has zero tolerance to advantage play. Any player who will try to gain advantage of casino welcome offers or other promotions agrees that Company reserves the right to void bonuses and any winnings from such bonuses, for the reasons of:

16.3.1 use of stolen cards;

16.3.2 creating more than one account in order to get advantage from casino promotions;

16.3.3 any other actions which may damage the Casino;

NON TRANSFERABILITY

17.1 You can not assign, pledge or transfer ownership under any title whatsoever to claims arising from these Terms and Conditions, the use of the Website or participation in the Games against the Casino without consent of the Casino. This prohibition is designed as a non-transferability clause ex article 83 paragraph 2 of book 3 of the Civil Code and includes the transfer of any assets of value of any kind, including but not limited to ownership of accounts, winnings, deposits, bets, rights and/or claims in connection with these assets, legal, commercial, or otherwise. The prohibition on said transfers also includes however is not limited to the encumbrance, pledging, assigning, usufruct, trading, brokering, hypothecation and/or gifting in cooperation with a fiduciary or any other third party, company, natural or legal individual, entity in any way shape or form.

ARBITRATION

18.1 All disputes which may arise between you and the Casino including their successors in title under general or special title as a result of these Terms and Conditions or as a result of further agreements and other acts in connection with these Terms and Conditions shall be settled exclusively by arbitration in Cyprus and in accordance with Cyprus Civil Procedure Rules.
